SVC Vision

The overall vision of the Seed & Venture Capital (SVC) Scheme is to increase the availability of risk capital for start-ups and scale ups. The programme also supports economic growth through continued development of the Seed and Venture Capital industry in Ireland to achieve a more robust, commercially viable and self-sustaining sector.

Strategic Objectives

Develop a sustainable VC industry in Ireland

Strengthen diversity across the funding ecosystem

Support sectors of strategic national importance

Leverage increased private sector capital

Drive economic impact – jobs, exports and innovation

EI has been a cornerstone of Irish Venture Funds since 1994.

2024 – A Year in Review

Since 1994 EI has committed almost €700m to support and sustain national and regional innovation through the Seed and Venture Capital (SVC) Schemes. This funding has leveraged an additional ~€1.5bn into the Irish VC ecosystem. The most recent is SVC Scheme 2019-24, under which €186m was allocated to 15 funds, investing at the Seed to Series A+ stages. This scheme is now fully allocated and during 2024 a new €250m SVC Scheme 2025-29 was announced by the Minister of the Department of Enterprise, Tourism & Employment. This is a 40% increase on the size of the prior Schemes, reflecting the impact that this initiative has on the early-stage market for innovative companies in Ireland.

The fund managers supported under the Schemes are looking for the best of Irish innovation, companies that can compete on the global stage, and who typically require significant equity investment to develop their products and services.

In terms of the venture ecosystem at home and abroad in 2024, sums invested increased whilst round numbers dropped. Pitchbook tracking of European activity confirmed that the trend towards larger but fewer rounds continued from the prior year. Deal value declined by 8% whilst the number of investment rounds fell by over 23%. 'Capital remained tight, and the outlook remains difficult with fewer venture capital teams succeeding in raising funds whilst, those that did, saw their fund sizes increase, essentially a mirroring of the company level venture funding activity.

Domestically, the Irish Venture Capital Association (IVCA) reported that deal value on the island of Ireland was up 9% to €1.48bn, with a clear bias towards >€5m deals and a squeeze on rounds at seed stage. The number of deals was flat on 2023, indicating that the Irish market did not experience the extent of the European pull back.

Against this backdrop, the funds supported by our SVC Schemes have continued to play a critical role in underpinning the ecosystem in Ireland. In 2024, these funds invested €101.9m in Irish companies, an increase of 19% in deal value when compared to 2023. In line with the European trend, the number of Irish companies supported decreased by 19% to 74. The average cheque size invested by SVC backed venture funds increased by 49% to €1.4m.

It is important for the Irish market that there is a flow of equity capital for early-stage companies. During 2024, Enterprise Ireland directly supported 157 start-ups with investment of €27.6m, an increase from 130 and €24m respectively in 2023. 90 of these companies were at seed stage through the High Potential Start-Up programme, and the balance through the Pre-Seed Stage fund.

A key objective of Enterprise Ireland's SVC Schemes is to create an environment where founders from all backgrounds can start, innovate and grow internationally from anywhere in Ireland. During the year, Enterprise Ireland in partnership with the Irish Venture Capital Association (IVCA) ran the 'Road to Investment' VC programme for women entrepreneurs.

In 2024, 22% of SVC supported companies in Ireland were women led, and it is our ambition to continue to drive for increases in this market share. One way we believe we can influence this is by supporting gender balanced venture teams, and the majority of our supported fund managers have women at the partner or investment manager level.

In late 2024, EI launched the 1st Call under the SVC Scheme 2025-29. The timing is important so that fresh capital can be brought into the Irish market addressing some of the capital squeeze that is evident at the €5m and below stages. Enterprise Ireland's strategy for the life of the Scheme is to support early-stage companies in Ireland, and a significant portion of the €250m Scheme will be allocated to Series A stage funds.








Sectoral Breakdown of Irish Investments






Sectoral Breakdown of Irish Investments



Sectoral Breakdown of Irish Investments
